




 - Enhance public understanding of independent higher education's contributions to society




CIC Membership



Undergraduate Enrollment by Age Group (Fall 2013)






CIC vs. Public Institutions

Core Revenues per Student FTE (2012–2013)




CIC vs. Public Institutions

Core Expenses per Student FTE (2011–2012)




Graduation Rates


